General Document Request

Before we can begin the process of administering/probating your loved one's estate, it is important for us to have a general understanding of the estate and its assets. If possible, please bring with you to the initial meeting the following documentation:

1. Copies of existing planning documents, including wills, trusts, powers of attorney, health care directives, etc.
2. Copies of all deeds to real estate owned by the descendant.
3. Copies of the most recent statements evidencing ownership of bank accounts, investment accounts, retirement accounts, and annuities.
4. Copies of any stock or bond certificates.
5. Pre or Postnuptial Agreement (if applicable).
6. Long-term care policies (if any).
7. Divorce Decree or Property Settlement Agreement for divorce under which continued obligations exist.
8. Last 3 years of personal income tax returns.
9. Last 3 years of any corporate, partnership, gift tax, estate tax, or trust tax returns.
10. Death Certificate (if issued).

Affirmation
